## Acknowledgement, Waiver and Release

IN CONSIDERATION of Muldrew Lakes Cottagers' Association permitting me and/or my child(ren) to participate in the SWIM AND CANOE REGATTA (the "Event") and any or all of its programs or activities, I, \_\_\_\_\_ (PRINT FULL NAME) and my heirs, executors, administrators, successors and assigns (collectively, the "Releasor"), hereby irrevocably and unconditionally:

1. State that I am 18 years of age or older and am competent to make any determination respecting my and/or my child(ren)'s participation in the Event;
2. Acknowledge and accept that participation in, attendance at and/or transportation to and from the Event involves certain risks, dangers and hazards, including personal and bodily injury, death, partial disability, property damage and/or loss. I understand, have considered and evaluated the nature, scope and extent of the risks, dangers and hazards involved, and I voluntarily accept and fully assume all such risks, dangers and hazards, including the possibility of personal and bodily injury, death, partial disability, property damage and/or loss of any kind, that may result from my and/or my child(ren)'s participation in, attendance at and/or transportation to and from the Event;
3. Fully and forever release and discharge Muldrew Lakes Cottagers' Association and its board, directors, officers, agents, officials, servants, employees, volunteers, administrators, instructors, coaches, representatives, heirs, successors and assigns (collectively, the "Releasee") of and from any and all causes of action, lawsuits, claims, actions, demands, suits, debts, duties, losses, damages, covenants, injuries, costs, expenses (including legal fees and disbursements) and liabilities of whatever nature and kind, whether in equity or at law, of or to me, my child(ren) or any other person, directly or indirectly arising out of or in connection with my and/or my child(ren)'s participation in, attendance at and/or transportation to and from the Event, whether prior to, during or subsequent to the Event;
4. Agree not to make claim or to commence or take proceedings against any other person, firm, partnership, business or corporation who or which might claim contribution from, or to be indemnified by, the Releasee, under the provisions of any statute or otherwise in respect of those matters to which this Acknowledgement, Waiver and Release applies;
5. Agree not to initiate any lawsuit, court action or other legal proceeding against the Releasee, nor join or assist in the prosecution of any claim for damages which anyone may have, on account of loss, damage, or injury sustained by me, my child(ren) or others, howsoever occurring, whether by negligence or otherwise, arising out of or in connection with my and/or my child(ren)'s participation in, attendance at and/or transportation to and from the Event, and I waive any right I may have to do so;
6. Undertake and agree to hold harmless and indemnify the Releasee from and for any and all damages, sums, costs or expenses (including legal fees and disbursements) incurred or suffered by the Releasee or paid by the Releasee to any person in connection with any loss, damage, injuries, causes of action, claims, demands, lawsuits, expenses and any other liability of any kind, sustained by me, my child(ren) or others, in connection with my and/or my child(ren)'s participation in, attendance at and/or transportation to and from the Event;
7. Waive my insurers' right to make a claim against the Releasee based on insurance payments made to me or on my behalf for any reason. This means my insurers have no right of subrogation;
8. Acknowledge and agree that the Releasee does not provide any insurance, either life, medical or liability, for any illness, accident, injury, loss or damage that may arise in connection with my and/or my child(ren)'s participation in, attendance at and/or transportation to and from the Event;
9. Authorize the Releasee the irrevocable right to use and/or release information without restriction, photographs and/or video/audio recordings concerning myself and my child(ren) for use in advertising, displays, printed materials, publications, websites (including social media sites such as Facebook, Flickr, Twitter, Instagram etc.) and audio-visual or broadcast materials. The release of such information, photographs and/or video/audio recordings shall not be regarded as a breach of confidentiality on the part of the Releasee and I waive all claims against the Releasee for compensation or otherwise;
10. Understand and agree that as a participant I and/or my child(ren) are responsible to act in a safe and responsible manner, to follow the instructions or directions of the person(s) in charge of the Event, to obey requests to comply with safety regulations as directed by the person(s) in charge of the Event, and to ensure that I and/or my child(ren) obtain and wear any appropriate safety equipment necessary for participation in the Event; and
11. Understand and agree that I and/or my child(ren) will be solely responsible our actions, and will not endanger the safety of myself/ourselves or others at the Event, or when travelling to and/or from the Event.
